It gives me great pleasure to write my first article for the Mask in my official capacity as Executive Secretary. Allow me to take this opportunity to give you some insight as to what has happened since we adjourned the 36th Grand Council.

Bill Fitzpatrick and I were faced with the task of moving the Central Office from St. Louis, Missouri to Stockton, California by January 1, 1973. From the surface this appeared to be a relatively easy task to accomplish. However, our major concern was to effect a move which would result in very little inconvenience, if any to our brotherhood.

After considerable contemplation it was decided that December was not an ideal time of the year to move the Central Office especially when our chapters would be in need of our services. Bill and I agreed that a gradual move should take place, completing the move by

June 1, 1973. This has proven to be a wise decision, as we will be able to operate to peak efficiency serving our collegiate and graduate chapters at a time that is most important to them.

Bill Fitzpatrick, by virtue of his dedication to Kappa Psi is presently supervising the Central Office under my direction. Without Bill's help, I doubt that the transition would be as smooth as it is going.

As I had promised in New Orleans, the operations of the Central Office are undergoing examination in an attempt to operate more efficiently at reduced cost. We have been making progress in this direction but it is still too early to assess our position. Computerization of the Central Office has been one of our priorities and I am happy to report that we are making headway in this direction. Computerization will enable us to reduce cost further and yet respond quickly and efficiently to our membership.

Providing additional services to our members is also taking top priority in the Central Office. Programs are presently being developed which should prove exciting and beneficial to our Fraternity.

I would like at this time to extend my sincere appreciation to Bill Fitzpatrick for his guidance, both past and present in assisting me in the operation of the Central Office.

Now is the time of the year for that annual accounting with the Internal Revenue Service. For many this means several long nights of balancing figures and double checking to be certain that all inclusions and deductions are properly accounted for. The annual game of trying to beat the Federal Government actually involves two concepts, tax evasion (improper) and tax avoidance (proper).

The concept of tax evasion refers to the non-payment of taxes that should have been paid. This is generally accomplished by the falsifying of figures or the intentional concealment or omission of necessary information. This type of activity can lead to an audit of tax forms and if found to exist can be the basis for fines and/or prison terms.

The concept of tax avoidance, on the other hand, is recognized by the Internal Revenue Service as permissible activity. It refers to the delaying of tax on income to a year in the future when the tax bracket may be lower. There are requirements which must be met, but the end result can be a great tax saving. Most taxpayers do not have the resources to take full advantage of these provisions but the self-employed businessman does have a very important tax avoidance provision available to him. A Pharmacist, for example, who owns his own pharmacy, may establish his own retirement plan. He can set aside part of his annual income and, in doing so, defer the tax on this income until his retirement. The net result is a lower tax liability in the current year and probably a lower tax for this income in the year it finally is claimed. Very often the procedure involves only the opening of a special account with a bank or mutual fund.

Another part of the tax avoidance theory and perhaps the major concern of everyone is whether certain expenditures can be deducted. One very familiar deduction to the Pharmacist is the medical deduction allowed for drugs. This allows the taxpayer to deduct from his income the cost of all medicines for his family. There are a couple of idiosyncrasies however. Vitamins are deductible only if prescribed by a physician to cure a specific illness. Vitamins which the taxpayer takes voluntarily as a dietary supplement but not on the order of a physician do not qualify for the deduction. In like manner, birth control pills (although Rx



only) taken for the purposes of family planning do not qualify for the deduction because this is deemed only for convenience and not as a cure for a specific disease. Birth control pills do qualify for the deduction if the prevention of pregnancy is deemed necessary to preserve the health of the mother.

Some other deductions which the Pharmacist may look for include dues paid to professional organizations like APhA, ASHP, NARD, State and Local Associations, and KAPPA PSI. Expenses incurred in continuing education programs (including food and lodging when applicable) are deductible even if the courses are not required for license renewal. This deduction is in sharp contrast to the costs in obtaining the license originally. The theory employed is that the cost of acquiring the tools (the degree and the license to practice) must be borne by the taxpayer but the cost of maintaining the tools (continuing education) may be deducted from current income. It should be noted that a change of profession (a pharmacist returning to medical school) does not qualify

for a deduction because this is not sharpening but rather acquiring.

If an employer requires his employee Pharmacist to wear a certain type of dispensing jacket or uniform and the employee must buy these uniforms, then the cost of acquiring, laundering, and maintaining these uniforms is deductible from the employee's taxable income. If however these jackets are supplied by the employer, there is no deduction allowed.

A very troublesome area of deduction to many is the business entertainment expense. Past abuses have caused strict regulations to be promulgated governing this particular deduction. The most recent regulation requires the showing of business transacted as a result of the business entertainment if the expense is more than \$25.00. It goes without saying that restaurant checks, ticket stubs, receipts, and sales slips must be saved in order to prove the deduction. Finally the IRS requires the taxpayer to keep a diary of business expenses which indicates date, time, place, total bill, who was present, what was discussed, and what percentage of the expense is deductible. The most often used test for the deduction is the "quiet business lunch" doctrine. The theory is that it is extremely difficult to discuss business with bands playing, go-go girls dancing, and at small tables clustered closely together.

Although there seem to be many restrictions on the filing of tax forms, it should be remembered that the man who is honest will not have trouble with the tax people. The person who tries to defraud the IRS will someday trip a switch in the master computer of the IRS and start a process known as an audit. The audit may be very informal consisting of the exchange of a few letters or may be carried to the point of a full blown trial in the U.S. District Court.

As a final thought to those of you who travel, the next time you are driving South along U.S. Route 81 in the scenic and beautiful Shenandoah Valley and approaching Martinsburg, Virginia, say a prayer or cast a spell because you will pass the building housing the master computer for the Internal Revenue Service. It is from the memory banks of this computer, "THE MARTINSBURG MONSTER", that your past, present, or future tax problems originate.

The Provinces Report

Province I

The 1972 Province I Assembly was held on November 10 and 11 at the Willimantic Motor Inn, Mansfield Center, CT and the University of Connecticut, Storrs, CT.

The Friday evening program consisted of registration and a social hosted by the Brothers of the Connecticut Graduate Chapter at the Inn.

Satrap Gary Hall, Albany Graduate Chapter, called the first business session to order at 9:00 A.M. on Saturday at the Willimantic Motor Inn. Grand Officers recognized were: Dr. Norman A. Campbell, Grand Regent, and Dr. Benjamin R. Hershenson, First Grand Vice Regent.

Reports of officers were presented by Satrap Hall, Secretary-Treasurer David H. Crombe (in absentia — on sabbatical leave in Germany) and Assembly Chairman John Ferrari.

Brother Hershenson presented the report from Alpha Chapter in the absence of newly appointed Province Supervisor John Atkinson, Jr.

Following luncheon, the second session was convened at the School of Pharmacy, University of Connecticut. Chapter reports, committee reports and an open forum on chapter problems and programs constituted the major portion of the afternoon session.

Following the banquet meal at the Inn, representatives from Perception House, a drug rehabilitation center, presented a forum. Grand Regent Campbell installed the new officers to close the Assembly.

The 1973 Assembly will be held in Boston.

Province II

The 1972 Province II Assembly convened October 29 at Quality Court Motel, Carlisle, Pennsylvania. Twenty nine Delegates, representing seven of the ten Chapters were called to order by Second Grand Vice Regent Jack Atkinson and Brother Bruce Martin acting for the Province.

Brother Leo Davis, Province II Delegate to the 36th Grand Council reported to the Assembly on that meeting. In his review, Brother Davis reported a lack of representation from the Chapters of Province II. In general, he was of the opinion that the meeting lacked the usual enthusiasm evidenced at such events. He had high praise, however, for the individual workshops chaired by Members of the National Executive Committee. These "rap sessions" provided all Delegates an opportunity to review the operations of the Fraternity during the last three years.

Considerable discussion took place concerning the special problems of Omega Chapter (Rutgers) since the College of Pharmacy there moved to new quarters. The Assembly voted \$75 dollars, matching funds, to assist Omega Chapter. The Brothers in the Philadelphia area will assist by attending one or more meetings at Rutgers.

Election of Officers was conducted at the afternoon session. Those elected were: Dean Bruce Martin (Pittsburgh Graduate) — Satrap; James De Paolo (Delta Epsilon) — Vice Satrap; Robert Cornell (Eta) — Secretary-Treasurer; Frank Power (Eta) — Chaplain; Dr. Gerald O'Hara (Philadelphia Graduate) — Historian.

Concluding business, the Assembly acted on several amendments to the By-Laws. The Delegates approved travel re-imbursements for Chapters in attendance at Assemblies at the rate of 5¢ per mile, round trip. In addition, the travel expense for the Province Delegate to the Grand Council was established as round trip tourist air fare. The Assembly adjourned following installation of Officers by Second Grand Vice Regent Atkinson.
