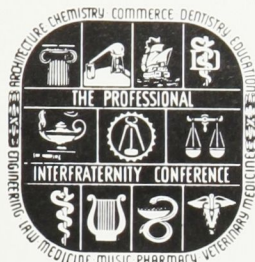

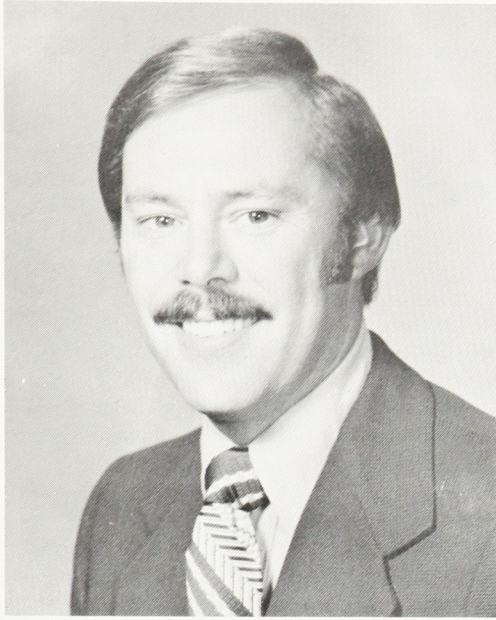

# FROM THE CENTRAL OFFICE



## Greetings:

By the time you receive this Mask, the year 1975 will be a thing of the past. However, 1975 will not be forgotten as it marked a year of growth and accomplishment. Kappa Psi has increased its collegiate membership in 1975 confirming the national trend of renewed interest in fraternity system on our nations campuses. To meet the demands and problems associated with this growth, Grand Regent Fitzpatrick has visited and represented the Executive Committee and Central Office on numerous chapter visitations. In addition, he officiated at the chartering ceremonies for Delta Iota chapter, located at Florida A & M. The Grant Regent authorized other Executive Committee members to act upon his behalf when his schedule would not permit him to leave St. Louis. To complete the spectrum, each Province Assembly held during 1975 had a Grand Officer or Executive Committee member in attendance. This past year also saw the passage of Title IX, or better known as the sex discrimination bill. The issues are still confusing, however in anticipation of its passage, Kappa Psi has changed its Constitution and By-Laws to conform to the current law. Last September 28th marked the convening of the Executive committee Meeting in Philadelphia, Pennsylvania. The meeting was long and tiresome but very productive. Many directives and decisions were made in regard to past, present and future fraternity policies. The minutes of this meeting were sent to each chapter outlining the details of the important decisions made on that day.

Effective January 1, 1976, Mr. Robert G. Fisher resigned his position as Assistant Executive Secretary. Bob is manager of Pay 'n Save Pharmacy in Modesto; this responsibility, his recent marriage and other responsibilities, make it very difficult for him to adequately serve the fraternity. He has done a tremendous job during the past three years and has agreed to help whenever he can to best serve Kappa Psi.

According to the Constitution (1974) Page 17, By-Law VIII, Paragraph 60, Section 4, I am allowed to appoint an official assistant with the approval of the Executive Committee. I am still a firm believer that an assistant should be close by to be of any help. Consequently, I have asked Dr. Christopher Gong, with the Grand Regent's approval, to serve as my Assistant Executive Secretary.

He is thoroughly familiar with the office and is aware of our problems, goals and achievements. I feel his service to our fraternity would be an asset.

# 38TH GRAND COUNCIL CONVENTION JULY 4, 5, 6 AND 7 - 1976

## PHILADELPHIA — THE BICENTENNIAL CITY

In 1976, the United States commemorates a year-long celebration of its 200th birthday. Philadelphia, the nation's first capital, will be the major focal point of the long awaited Bicentennial Celebration with new programs, new buildings and a whole calendar of special events and activities throughout the city. In fact, the Bicentennial era has already begun in Philadelphia with many new special attractions already open to the public. Most of these will be permanent and continue through 1976 and the years ahead, making Philadelphia an exciting place to be throughout the Bicentennial era.

Philadelphia is still Benjamin Franklin's city. Institutions he founded, plans he made, places he walked and things named in his honor intrigue 20th century visitors and continue to influence the daily lives of Philadelphians.

Franklin arrived in Philadelphia in 1723, a skinny 17-year-old runaway from Boston. By the time of his death in 1790, the city was his. He had organized the fire department, planned the early police force, suggested the street paving, designed the street lights and founded the first library, hospital, fire insurance company, college and other institutions.

Money he left the city in his will still benefits it, and won't be entirely disbursed until 1990.

For many years, one of the favorite sightseeing spots in Philadelphia has been Franklin's grave.

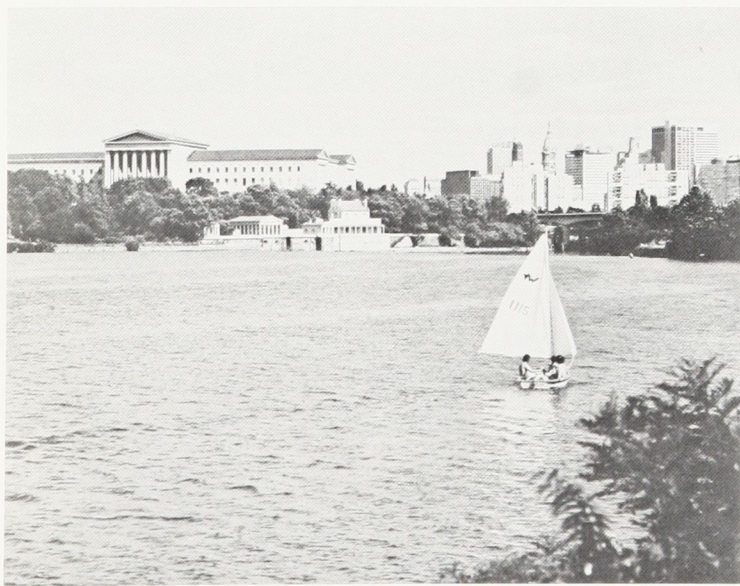
He and his wife, Deborah, were buried in a quiet corner of the Christ Church Burial Ground, at 5th & Arch Sts., under flat stones of a severe simplicity Franklin designated in his will.

So many visitors wore a path to that quiet corner of the cemetery that finally, a grilled opening was made in the brick wall, opening the grave site to the Arch St. sidewalk. Tourists and residents throw pennies on the grave for luck.

A more lively memorial to Ben Franklin is being developed for nation's Bicentennial by the U.S. National Park Service, as part of Philadelphia's Independence National Historical Park.

# KAPPA PSI HISTORY

## 40 YEARS AGO

### 1936—NATIONAL CONVENTION YEAR

As hastily announced in the November *The Mask*, 1936 is the year for the next scheduled National Convention. When 1932 rolled around, everything was in the midst of the "Great Depression." Recognizing the plight of the vast majority of our collegiate chapters, due to marked decreases in the student bodies and the financial inability of many eligible students to join fraternities, the Grand Chapter submitted to the collegiate chapters the desirability and the practicability, under the circumstances, of holding a National Convention at the usual time, viz., the Christmas holidays of 1932. The chapters voted not to have a national convention, and instead authorized the officers of the Grand Chapter to meet, and to consider all matters of legislation, other business, recommendations, resolutions, and nominations for national or Grand Officers. This was done, and the proposals and recommendations of the Grand Officers submitted to the chapters for their final action and vote. In that fashion Kappa Psi, by the action of the chapters, handled the 1932 national convention problem without expense to the collegiate chapters or to the Fraternity at large.

## 10 YEARS AGO

### THE 33RD GRAND COUNCIL CONVENTION OF KAPPA PSI PHARMACEUTICAL FRATERNITY

The 33rd Grand Council Convention of Kappa Psi Pharmaceutical Fraternity was held at the Sheraton-Palace Hotel, San Francisco, California on December 27-30, 1965. This marked the 86th Anniversary of the Fraternity, having been founded at the Russell Military Academy in New Haven, Connecticut in 1879. In addition to guest there were 173 members who registered for the four-day convention. Fifty-one of the 54 Collegiate Chapters were represented as were 12 Graduate Chapters and 10 Provinces. Previous to the convention's opening joint meetings of Alpha Chapter and the Executive Committee were held on December 27 at which Grand Regent Glen J. Sperandio presided. Additional sessions of the group were held on December 30 after the close of the convention.

General Convention Chairman was former Secretary-Treasurer Frank H. Eby and local chairmen were Eugene Jorgensen of University of California and James C. King of University of the Pacific. Other committees of the convention were; Credentials, Herman C. Forslund of Oregon State University, Chairman; Registration, Nicholas W. Fenney (editor of *The Mask*) of University of Connecticut, Chairman; Nominations, Milton L. Neuroth of Medical College of Virginia, Chairman; and Transportation-Information Committee, Armen Melikian, Chairman.

The social program included a luncheon which was followed by a sight-seeing tour of San Francisco, and the 86th Anniversary Dinner on Wednesday evening in the Ralston Room of the Sheraton-Palace Hotel. During the Anniversary Dinner two presentations were made on behalf of the Fraternity, one to past Secretary-Treasurer and Mrs. Frank H. Eby by Editor of *The Mask* Nicholas W. Fenney, and the other to Mrs. Glen J. Sperandio by First Grand Vice Regent Walter R. Williams.

The Grand Council Convention closed with the installation of the following officers: Grand Regent Glen J. Sperandio, Purdue University; First Grand Vice Regent Walter R. Williams, University of Connecticut, Second Grand Vice Regent Leo A. Sciuchetti, Oregon State University, Third Grand Vice Regent James C. King, University of the Pacific, Grand Historian Norman A. Campbell, Massachusetts College of Pharmacy, Grand Counselor John Atkinson, Jr., Smith Kline & French Laboratories, and Grand Ritualist Richard M. Doughty, University of Kentucky. Gerald C. Henney, St. Louis College of Pharmacy was re-appointed Executive Secretary and Nicholas W. Fenney, University of Connecticut was re-appointed Editor of the fraternity's publication, *The Mask*.

The 33rd Grand Council Convention adjourned Thursday noon, December 30, 1965. The next national convention will be held in the summer of 1967.

## 30 YEARS AGO

### THE EXECUTIVE COMMITTEE

A meeting of the Executive Committee, Kappa Psi Pharmaceutical Fraternity, was held in Boston, Massachusetts on Tuesday and Wednesday, January 8-9, 1946. Brothers Wood, Klemme, Kelley, Curry and Ridgeway were in attendance.

The first session was held at the home of Grand Secretary-Treasurer Kelley. Grand Vice Regent Wood called the meeting to order at 2:40 P.M. on January 8, 1946.

A letter from Grand Vice Regent Eby was read. Brother Eby stated that illness prevented him from making the trip to Boston and he suggested that Brother M. W. Quimby—Grand Council Deputy at Mu Chapter—be invited to take part in the deliberations of the Committee. This suggestion was unanimously adopted and Brother Quimby was asked to serve as Secretary pro tem.

### A REPORT OF THE TWENTY-EGHT NATIONAL GRAND COUNCIL CONVENTION OF KAPPA PSI PHARMACEUTICAL FRATERNITY

The Twenty-Eighth National Grand Council Convention of Kappa Psi Pharmaceutical Fraternity was held at the Edgewater Beach Hotel in Chicago, Illinois, on December 27, 28, and 29, 1955. Members of Chi Chapter at the University of Illinois and the Chicago Graduate Chapter served as hosts. These meetings represented the seventy-sixth anniversary of the founding of the organization.

Donald F. Gorski and Richard J. Mikyska, members of the Chi Chapter in the host city served as general convention chairman and general co-chairman respectively. Nicholas W. Fenney, Grand Regent, served as chairman of the program committee, along with Frank H. Eby, Grand Secretary-Treasurer, and Donald F. Gorski of Chi Chapter of the University of Illinois.

In addition to a number of guests there were 195 members registered for the meetings. Of this number 116 were delegates and alternate delegates. TO CRUSH OR NOT TO CRUSH, THAT IS THE QUESTION

Many pharmacists are becoming involved in supplying medication to geriatric patients. Questions are often asked, either by the patient or the nurse, if a certain medication can be crushed and placed in applesauce or other foods. With the knowledge of a few basic facts, the pharmacist should be able to answer any question concerning this problem. In some cases, liquid preparations of the medication are on the market. In other instances, the medication can be crushed without the loss of activity or an increase in toxicity. Here are some considerations to be kept in mind when answering this question.

Many types of coating materials are available for use in the pharmaceutical industry. However, coatings are selected to serve specific functions and it becomes necessary for a pharmacist to understand the function of a tablet coating before he can decide if the tablet may be crushed prior to administration. Tablet coatings are formulated to:

- a) Impart color for identification and to improve pharmaceutical elegance (Thorazine)
- b) Disguise taste and prevent aftertaste. (Chloral Hydrate)
- c) Prevent decomposition of the drug by stomach acidity. (Erythromycin)
- d) Minimize gastrointestinal irritation (Enteric coated preparations)
- e) Delay the release of medications (Extentabs, Filmtabs)
- f) Prevent staining (Povan)
- g) Enable Medication to reach the lower gastrointestinal tract before dissolving (Dulcolax)
- h) Add stability to the product by:
  - 1) Preventing oxidation
  - 2) Place part of the active ingredients in the coating to prevent its interaction with components in the body of the tablet and/or to produce differences in release rates of medications (repetabs).

Some drugs are prepared as layered tablets. If the layering is to add stability to the preparation, they may be crushed prior to administration. However, if the drug is layered in such a manner to allow the outside coating to be dissolved and utilized immediately while keeping the inner core intact for sustained action, the drug should not be crushed. (Tepanil, Tenuate)

A tablet may be crushed and its contents added to applesauce if the coating is present only to impart color or improve pharmaceutical elegance. If the coating serves other purposes, crushing the tablet will either decrease the effectiveness of the drug or it will increase the incidence of side effects.

Hard gelatin capsules may be opened and the contents can be added to foods. This is acceptable with Pavabid and spansule preparations of SKF. However, one should urge the patient to swallow the food drug mixture rather than chewing it because chewing may disrupt the integrity of the granules and alter the effectiveness of the drug. One should recognize the fact that many drugs that are placed into capsules are relatively non-palatable. Mixing the contents of capsules with applesauce, etc, may reduce product acceptance and compromise patient compliance.

Soft gelatin capsules may be opened and the contents mixed with applesauce. However, not only are they likely to produce a disagreeable taste, but it is doubtful if the full dose will be administered.

Below is a partial list of the drugs which should not be crushed before administering to patients. In some cases, liquid preparations are commercially available.

Erythromycin - decomposed by acid	Povan
Chloral Hydrate - taste and dosage	Filmtabs
Vitamin A - taste and dosage	Triaminic
Enteric coated tablets	Singlets
Thyroid	Drixoral
Dulcolax	Repetabs

Some geriatric patients are not fully capable of maintaining their equilibrium under all conditions and occasionally they may fall. These falls are of special consequence to the elderly because the skeletal structure of the body starts to deteriorate after the age of 35 years and thus the bones of an elderly person cannot take the stress placed on them by a fall. This especially true of women over the age of 50 years. It is a well documented fact that after menopause, osteoporosis may develop more rapidly than during the premenopausal years. Some physical considerations (Canes, handrails, wheelchairs, etc.) may help somewhat in preventing bone breakage, but certain pharmacological considerations might also be in order. Osteoporosis may be aggravated by drugs which induce microsomal enzyme metabolism, e.g. glutethimide, barbiturates, etc. Reports have cited evidence which indicates that significant increases in the rate of vitamin D metabolism can be observed in patients taking drugs which induce enzymes. Vitamin D is metabolized more rapidly in these patients and hypovitaminosis D can allow for further deterioration of bone. Many patients with osteoporosis have limited exposure to sunlight. Elderly ladies frequently dress in long dresses and even if they do get outside occasionally, they may not get enough sunlight to activate the vitamin D precursor in the body to the more active species. One might help prevent osteoporosis by carefully monitoring the drug regimen. Drugs which induce enzymes might be eliminated from the regimen and replaced with other suitable agents. Vitamin D supplements may be necessary and one should allow and encourage the patients to spend some time outdoors. (Geriatric bikinis may become in demand.) If necessary, estrogen therapy may be useful in controlling osteoporosis in women. The value of fluoride salts and thyrocalcitonin is not yet clear.

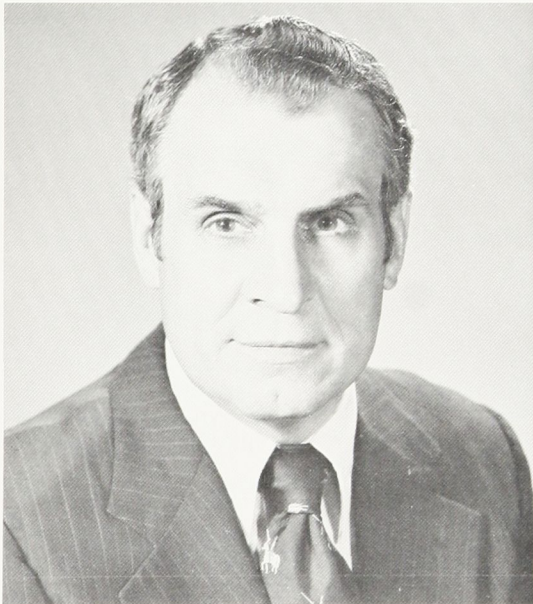
- **Michael I. Smith** (Epsilon) was elected Satrap of Province VIII. Brother Smith is Assistant Editor of *The Mask*.

# **BROTHER ALBERT DOERR NAMED RECIPIENT OF 1975 REMINGTON MEDAL**

Albert Doerr (Beta Sigma) of North Dakota has been named the recipient of the 1975 Remington Honor Medal.

The selection of Doerr for the Medal was announced by Remington Honor Medal Committee chairman Arthur G. Zupko.

Pharmacist Doerr becomes the 49th Remington Medalist. The award was conceived in 1918 by the late Hugo H. Schaefer in memory of Joseph P. Remington. The judging committee consists of APhA past presidents, with the award made on the basis of individual service to American pharmacy.

The Medal is presented at the Remington Medal Dinner during the 1976 APhA Annual Meeting in New Orleans.

In announcing the 1975 Remington Medallist, Dr. Zupko noted that Pharmacist Doerr was selected "on the basis of his dogged determination against seemingly hopeless odds to bring about the reversal of the Liggett decision by the United States Supreme Court. His action reflects a profile in courage which is unique in the annals of American pharmacy. He also made significant contributions to the profession of pharmacy through sustained exemplary services over the years. He is highly deserving of this great honor."

When the Supreme Court on Dec. 5, 1973 held constitutional a North Dakota statute requiring that state pharmacists in good standing possess majority ownership of all state pharmacies, APhA executive director Dr. William S. Apple and NARD executive secretary Willard B. Simmons issued the following joint statement on behalf of the Committee on Pharmacy Economic Security (COPES):

"The reversal of the onerous Liggett decision resulted in the initiative of the North Dakota Pharmaceutical Association in obtaining state legislation to protect the integrity of pharmacy practice and the courage of the North Dakota Board of Pharmacy in defending a statute which protects the public health."

Albert Doerr has served as president and currently serves as secretary-treasurer of both the North Dakota Pharmaceutical Association and the North Dakota Board of Pharmacy.

Born March 23, 1904 in Lehr, North Dakota, the 1975 Remington Medallist earned his bachelor of science in pharmacy from North Dakota State University in 1928.

# **SAPhA PRESIDENT COOPER'S TESTIMONY**

**Pharmacy Colleges Grew  
to "unnatural" and "unprecedented"  
Enrollment Levels**

In testimony in front of Senator Kennedy's subcommittee writing a new helath manpower law, SAPhA President John F. Cooper (Beta Eta) charged that pharmacy colleges grew to unnatural and unprecedented enrollment levels to get federal capitation grants which they don't need to maintain clinical pharmacy curricula. SAPhA strongly urged an end to federal capitation grants for colleges. Brother Cooper's testimony contradicted earlier testimony from the American Association of Colleges of Pharmacy (AACP) claiming that colleges must have federal money to continue quality clinical education, required for accreditation by the American Council of Pharmaceutical Education. Dr. John V. Bergen (Eta), President of Philadelphia College of Pharmacy and Science was a witness for the AACP. SAPhA contends that federal capitation money has created an undesirable disruption of the laws of supply and demand for pharmacy.

The Saturday morning Assembly business session was opened with appropriate ritual by Satrap Edward T. Kelly II and Province I Supervisor, Immediate Past Grand Regent Norman A. Campbell. Professor Rinaldo V. DeNuzzo, Grand Council Deputy of Beta Delta, brought greetings and welcome on behalf of Dean Walter Singer of Albany College of Pharmacy as well as the Albany Graduate Chapter. Regent Robert Marcone extended the greetings of Beta Delta.

Among the resolutions adopted was one mandating the appointment of a committee to investigate establishment of graduate chapters in Western Massachusetts and in Maine.

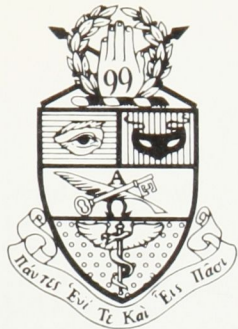

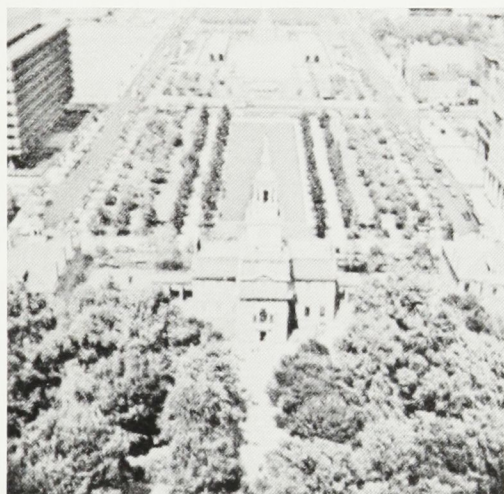
