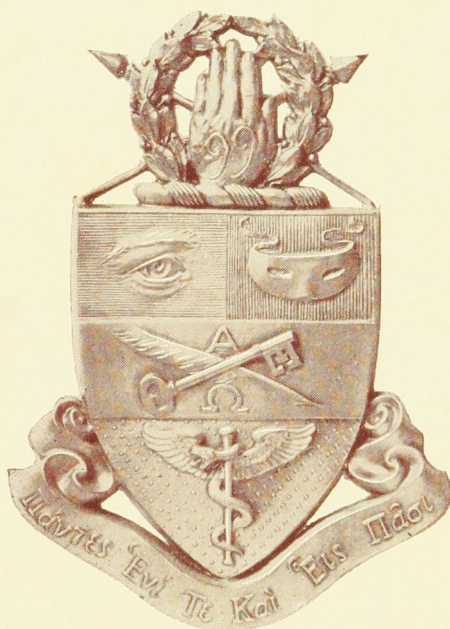

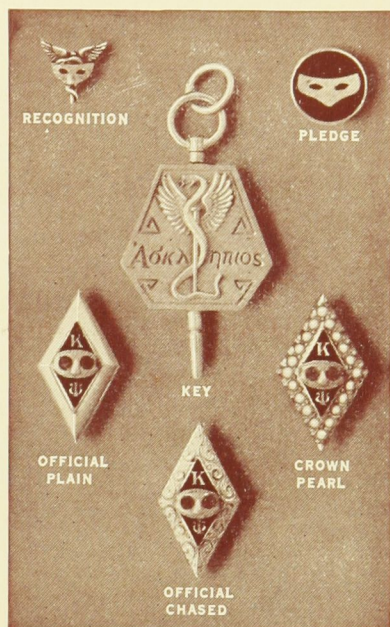

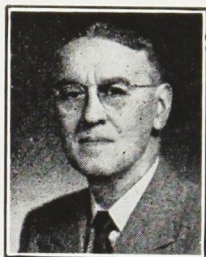

# Definitions of Interest

The following statement of definitions of college fraternities and societies has been prepared by the National Conference of College Fraternities and Societies, whose sponsors include: Association of College Honor Societies; National Association of Student Personnel Administrators (Deans of Men, Deans of Students, etc.); National Association of Deans of Women; National Interfraternity Conference; National Panhellenic Conference; Professional Interfraternity Conference; Professional Panhellenic Association.

## *Social Fraternities*

Men's Social College Fraternities are mutually-exclusive, self-perpetuating groups which organize the social life of their members, in accredited colleges and universities, as a contributing factor to their educational program; and draw their membership primarily from the undergraduate body of the institution.—*National Interfraternity Conference*.

Women's Social Greek letter Fraternities accredited by National Panhellenic Conference are primarily groups of friends whose chapters are in accredited colleges and universities but which in addition to their individual purposes are committed to cooperation with college authorities to maintain high social and scholastic standards and which do not limit membership to any one department or school of a college or university.—*National Panhellenic Conference*.

## *Professional Fraternities*

A professional fraternity is a specialized fraternity which limits its student membership to a specific field of professional education in accredited colleges and universities offering courses leading to recognized degrees therein; which maintains mutually exclusive membership in that field, but may initiate members of the general social fraternities; and which organizes its group life specifically to promote professional competency and achievement within its field. The professional fraternity confines its membership to qualified male students (and faculty members) in a particular profession who are pursuing an organized curriculum leading to a professional degree in that field, has a minimum scholastic requirement for membership usually above passing, elects its members after a careful investigation and generally by a unanimous secret ballot. It initiates its members early in their professional college life, enabling them to participate actively and beneficially in the professional aims of the fraternity, holds frequent meetings, conducts professional and social activities, and frequently maintains a chapter house or quarters. Professional fraternities also sponsor programs of special value to alumni members.—*Professional Interfraternity Conference*.

Professional Fraternity—a specialized fraternity for women which confines its membership to a specific field of professional or vocational education in accredited colleges and universities, and maintains mutually-exclusive membership in that professional field, but may initiate members of the social college fraternity.—*Professional Panhellenic Association*.

## *Honor Societies*

An Honor Society is an association of primarily collegiate members and chapters whose purposes are to encourage and recognize superior scholarship and/or leadership achievement either in broad fields of education or in departmental fields at either undergraduate or graduate levels. Basic standards and requirements for membership include the following:

DEAR BROTHER:

By early October, December, March, and June you are requested to prepare "News Letters" for publication in THE MASK. The material in these letters should concern the activities of your Chapter as well as other items of interest to your Graduate Brothers and to Kappa Psi men everywhere.

It is requested that you exercise great care in composing these letters. Kindly spell correctly and check grammatical construction so that readers of the published letters will be favorably impressed. The correct spelling of members' names is particularly important. Satisfactory letters result only if time and effort are put into their preparation.

It is also requested that you observe the following suggestions wherever possible:

- a. Send all Chapter Letters to the Editor at 179 Longwood Ave., Boston.
- b. Please use a typewriter with STANDARD (not "miniature") type, and prepare your letters with *double spacing*.
- c. Include an *original* and one *carbon copy*.
- d. Include chapter and school names in *capitals across the top of the first page of each letter*. (It is suggested that you refer to a recent issue of THE MASK in order to observe the form in which Chapter Letters are published.)
- e. Graduate Chapters need include only the chapter names.
- f. Be particularly careful about the spelling of members' names.
- g. Whenever photographs are submitted for publication be sure to include the names of those appearing in the pictures and to attach other information which you wish published beneath the pictures. (Protect photographs in such a manner that they will not become damaged in the mails.)

Your kind cooperation in this matter will be greatly appreciated.

"To the Home-Buying Veteran," a 32-page guide for veterans planning to buy or build homes with GI loans, is now available at all Veterans Administration offices.

VA said the pamphlet is designed to help World War II and post-Korea veterans get started on the right foot under the GI home loan program.

The pamphlet discusses what a veteran should look for in selecting the neighborhood, the lot and the house itself.

It also covers the costs of home ownership, the contract of purchase, final settlement or closing the loan, and what to expect before and after moving into a new home.

The responsibilities of the veteran home owner and what the VA can and cannot do to assist the veteran are also discussed.

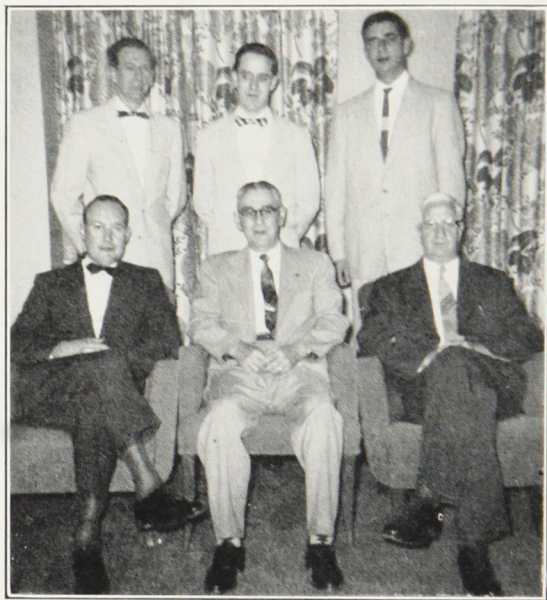
A copy of the pamphlet will be sent to each veteran applying for a certificate of eligibility for a GI loan. Veterans also may obtain a copy by writing the nearest VA regional office. There is no charge for the pamphlet.

# Executive Committee Meeting in Boston May 15 and 16, 1953

A meeting of the Executive Committee, Kappa Psi Pharmaceutical Fraternity,<sup>\*</sup> was held at the Hotel Statler, Boston, Massachusetts on Friday and Saturday, May 15-16, 1953. Brothers Eby, Kelley, Blythe, Dayton, Regrut, and Smith of the Executive Committee and Brother Quimby, Editor of *THE MASK*, were present at this meeting.

Grand Regent Eby called the meeting to order at 2:00 p.m. on May 15 and appointed Brother John J. Dayton, Jr. as *Secretary pro tem.* During the two-day meeting reports were given and various items discussed as follows:

1. Grand Regent Eby reported upon the ever increasing duties performed by his office. Correspondence had increased to several times the original volume of such work. Ten Chapter visitations were reported, Gamma Chi Chapter and, with the assistance of Grand Historian Fenney, Gamma Psi Chapter had been installed. Attendance at Province I, II, III Assemblies were reported. The "Handbook for Pledges" had, with the assistance of Grand Ritualist Wurster, been prepared, mimeographed, and distributed to the Chapters in mimeographed form with the request for constructive criticism prior to publication in a more permanent form.
2. The G.S.T. reported that the collegiate membership was slightly lower than at the same period in 1952. The finances were in excellent condition with all but two chapters paid in full to May 1, 1953. Attendance at Province III Assembly and a dozen chapter visitations were reported. The Arizona Graduate Chapter had recently been installed.



Brother Kelley also commended the Legislative Committee (Brothers Thayer, Hanmer, and Williams) for their fine work in revising the Constitution and Model By-Laws of the Fraternity. Attention was called to the installation of the Minnesota Graduate Chapter with Brother Goldner and Brother Wurster serving as installing Grand Officers. Visitations to the Chapters in California, Arizona, Washington and Montana had been made by Brother Fischer who also attended Province VII Assembly. Brothers Fenney, Thayer, Neuroth and Goldner had also made several chapter visitations and attended one or more Province Assemblies. Only Province VI had failed, up to May 1, to hold or schedule a Province Assembly.

3. Brother Smith, Chairman of the Scholarship Committee, reported on the work of his committee. Plans are being made that will result in the awarding of a scholarship to a Kappa Psi Brother doing graduate work. The Committee hopes that this award will be at least \$500.00. The Executive Committee requested Brother Smith to continue the work of his committee, report to the Grand Council Convention, and formulate plans for the first award to be made in 1954.

4. The Editor of THE MASK, Brother Quimby, presented a report of his work and stated that he hoped to publish many feature articles taken from the early volumes of THE MASK. The G.S.T. was authorized to obtain photostatic copies of any issues of MASK copies not now in the files. Brother Quimby was commended for his fine work which has brought about the great improvement in the appearance and contents of THE MASK.

5. 1953 Grand Council Convention. The voting by the Chapters for a Convention site showed no definite choice of a Convention City. After discussion the Committee voted that the 1953 Convention be held either in New York, Washington, D.C., or Cincinnati area. Brothers Eby and Kelley were authorized to investigate the facilities offered by these three sites and, after investigation, report their choice of a Convention City to the members of Alpha Chapter for final approval. It was moved and carried that the Convention dates be December 28, 29, and 30, 1953.

6. Miscellaneous.

A. The Grand Regent was directed to prepare and send to each Chapter a questionnaire concerning chapter activities, finances, and membership. The purpose being to streamline Chapter reports given at the Grand Council Convention.

B. The Grand Regent was authorized to prepare a uniform program to be used for the installing of new Chapters and to submit same to the Grand Council.

C. Discussion of a basic pledge program. That such a program is desirable, was agreed upon but no action taken.

D. Community Service Programs were discussed and it was regretted that such activities were not more generally reported for publication in THE MASK.

E. The Committee went on record as emphasizing the fact that all Kappa Psi jewelry, stationery, and other items bearing the insignia of Kappa Psi must be purchased from the official jeweler.

F. The present Province alignment was approved.

G. The Committee voted to emphasize the fact that "only students actually registered in Schools or Colleges of Pharmacy are eligible for Collegiate Membership in Kappa Psi."

H. The work of the Interfraternity Research and Advisory Council was discussed. The Grand Secretary-Treasurer was authorized to purchase sufficient subscriptions to *The Bulletin of the Interfraternity Research and Advisory Council* so that each Collegiate Chapter and each Graduate Chapter of Kappa Psi will have copies of same for one year.

I. Brother Dayton reported that Province VII Assembly wished to extend an invitation to Grand Council to hold the 1955 Grand Council Convention in Portland, Oregon. The Committee expressed its appreciation for this kind invitation and suggested that Province VII present this invitation to the Delegates at the 1953 Grand Council Convention.

7. The meeting adjourned at 5:00 P.M. on Saturday, May 16, 1953.

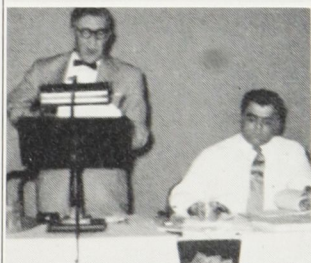
# Province I Assembly

The sessions of the N.C.C.F.S. were extremely interesting and this meeting will be more fully covered by later releases in the form of minutes.

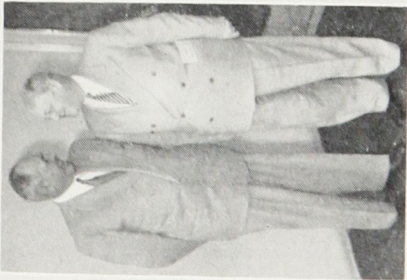

Many other items of interest were discussed but as they were largely matters of procedure they will not be reported here.

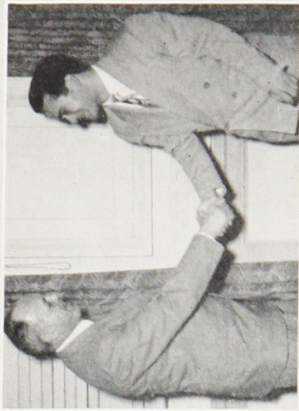

# Province VII Assembly

The Biennial Assembly of Province VII was held in Portland, Oregon, April 25, 1953. Chapters in attendance were, Beta Gamma of the University of California, Beta Zeta of Oregon State College, Beta Omicron of the University of Washington, and Seattle and Portland Graduate Chapters. Chapters at State College of Washington, Montana State University, University of New Mexico, and University of Arizona, namely Beta Pi, Gamma Eta, Gamma Rho, and Gamma Upsilon respectively, were not represented. Approximately sixty members were present.

Registration and breakfast was at the Multnomah Hotel, sponsored by Mutual Wholesale Drug Company of Portland. Business meetings were held at the Upjohn Company building, and were called to order at ten o'clock, by Satrap Herman Forslund of Oregon State College Faculty, Invocation by Elmer Porter. Leib Riggs then introduced the Mayor of Portland, Mr. Fred L. Peterson, who gave a short talk on "Progress of Pharmacy" (he too, being a druggist) and welcoming our delegation to the "City of Roses." Secretary and Treasurer Rob S. McCutcheon took the roll call, and seating of delegates, and gave reports as of Secretary and Treasurer of Province VII. Dr. Louis Fischer of University of Washington Faculty, First Grand Vice Regent of Kappa Psi, extended greetings and gave a brief résumé of the history of Kappa Psi, and the many advantages to its members. Satrap Forslund then appointed the Nomination, Resolution, Time and Place Committees, and the morning session then terminated.

Luncheon, sponsored by Northwestern Drug Company of Portland, was had at Burns Restaurant. Returning to Upjohn's Conference room at 1:30 the program continued with discussions of "Chapter Finances, Initiation" led by Larry Frisone, University of California, "Bookkeeping Methods of Chapter Funds" led by Jim Wilkins, University of Washington, "Fraternity Social Life" led by George Cholakian, Oregon State College, "Scholarships, Projects, Worthy Endeavors" led by Satrap Forslund, and "Fraternity Membership" led by Mel Larson, Oregon State College.

The Province VII By-Laws were next read, discussed, and some minor changes made. A motion to accept these By-Laws carried.

The report of the Nomination Committee by Wayne Mosby, Chairman, consisted of Brothers H. Forslund for Satrap; D. C. Brodie, University of California Faculty, Vice Satrap; Franklin Hart, Portland Graduate Chapter, Secretary-Treasurer; and J. R. Rosenquist, Seattle Graduate Chapter, Historian. The slate was accepted.

The report of the Time and Place Committee, Larry Frisone, Chairman, was accepted, and the next assembly of Province VII will be held in San Francisco, California.

The report of the Resolution Committee, Fred Meek, Chairman, suggested letters of appreciation be sent to sponsors of breakfast, luncheon, heretofore mentioned Upjohn Company for use of conference room, Haack Laboratories, Inc. for printed programs,

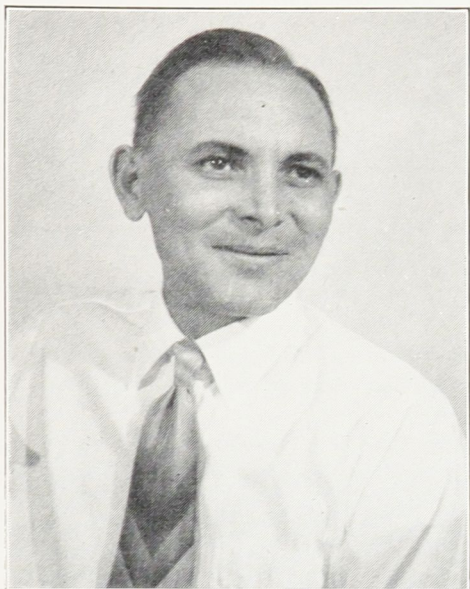

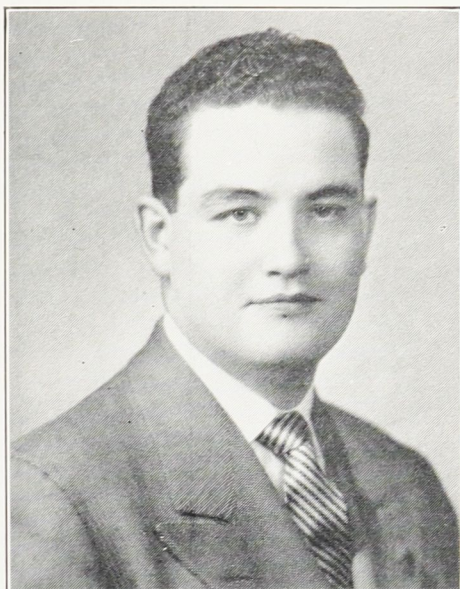

## Definitions of Interest

(Continued from page 100)

1. General honor societies which base membership eligibility primarily upon the attainment of high scholarship in a broad field of study shall elect members from the highest 20 per cent of the class in scholarship;
2. General honor societies which base membership eligibility primarily upon all-round leadership attainment in student affairs shall elect from the highest 35 per cent of the class in scholarship;
3. Departmental honor societies which elect persons actively interested in a specific field shall elect from the upper 35 per cent of the class in scholarship;
4. Election to membership shall be irrespective of membership in or affiliation with other organizations and associations;
5. Membership shall be conferred solely on the basis of character and specific eligibility;
6. No solicitation or propaganda, such as rushing and social pressure, shall be used to insure acceptance of invitation to membership;
7. Collegiate chapters of member ACHS societies shall be established only in four-year or more degree-granting colleges and universities that are accredited by the appropriate national or regional accrediting agency.

A recognition society is an organization which confers membership in recognition of a student's interest and participation in some field of collegiate study or activity with more liberal membership requirements than are prescribed for general and departmental honor societies.—*Association of College Honor Societies*.

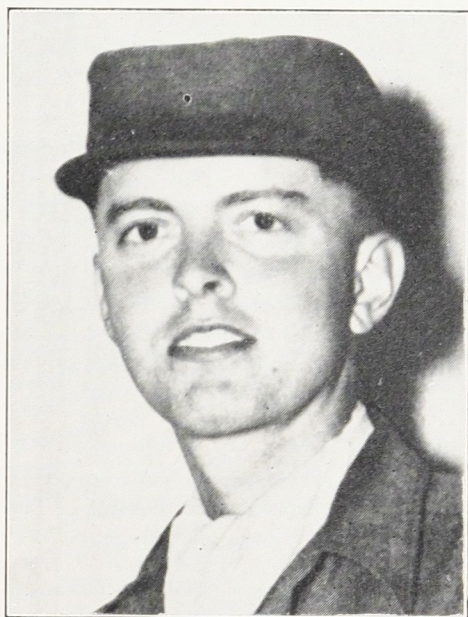

## Questions—Answers About Polio—'53

#### 1. *What is gamma globulin?*

A. Gamma globulin is the part of human blood that contains disease-fighting antibodies. It has been used for many years to combat measles and infectious hepatitis (jaundice). In 1952, March of Dimes scientists proved it to be an effective but temporary preventive of crippling caused by polio.

#### 2. *Can our children get gamma globulin (GG) for polio this summer?*

A. GG is in extremely short supply. There will be only about one million doses of GG available from now to September. There are about 46,000,000 children and adolescents in the age groups most likely to get polio.

#### 3. *Who will get gamma globulin this summer?*

A. The supply will probably be used in areas where the greatest number of cases occur. Most likely public health officers working with private physicians will administer the gamma globulin.

#### 4. *How will gamma globulin be distributed?*

A. The Office of Defense Mobilization (ODM), a governmental agency, is solely responsible for the distribution of the nation's supply of gamma globulin through state and territorial health officers. The National Foundation for Infantile Paralysis has *no* GG.

#### 5. *Can we buy GG?*

A. You should not be able to buy it anywhere. See your doctor. If it is possible for your child to have GG, it will be allocated to him through the health officer. There will be no charge for this GG. A private physician, however, may charge for his services in giving it. All commercially produced GG made from blood other than that donated to the

Red Cross is being purchased for the nation's stockpile by the National Foundation at an estimated cost of \$11,000,000 in March of Dimes funds.

6. *Why is it necessary to control all gamma globulin?*

A. It has been shown to be effective against three diseases—measles, infectious hepatitis and polio—and there is not enough GG available to treat all people who might get these diseases. Nor do manufacturers have enough equipment to increase production of GG this year. By placing all GG in one stockpile, it will be possible to prevent the maximum amount of disease with the limited supplies on hand.

7. *What's being done to get the most use out of GG supplies?*

A. Effective use of GG in 1953 is based on the following 3-point program:

1. Gathering of all available GG supplies into a national stockpile;
2. Allocation of GG to persons and areas where it will be most effective;
3. Teamwork by health authorities, physicians, public and private agencies, and BY YOU AND YOUR NEIGHBORS to assure community understanding and avoid unreasonable demands for GG.

8. *How much blood does it take to make one GG shot?*

A. One pint of blood yields just about the amount needed for an average GG polio shot. The same pint furnishes serum albumin for the treatment of wounded servicemen.

9. *What's the difference between GG and a polio vaccine?*

A. GG gives protection (about five weeks) by providing polio antibodies which fight against paralysis. A vaccine—composed of all three of the different polio viruses treated so as to render them non-infectious—will cause the body to produce its own antibodies which should last much longer. Polio vaccines are still in the experimental stage. *No vaccine will be available for widespread use during the coming polio season.*

10. *If we can't get GG, what can we do to protect our children?*

A. Pay attention to good health rules and precautions recommended by health authorities and the National Foundation for Infantile Paralysis:

1. Don't let children mix with new groups
2. Or get overtired
3. Or get chilled
4. But DO keep them clean

And consult your doctor if these symptoms appear: headache, fever, sore throat, upset stomach, stiff neck or back.

Keep in touch with your own local National Foundation Chapter and be guided by the recommendations of your medical and health authorities with regard to GG inoculations.

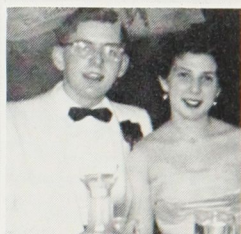
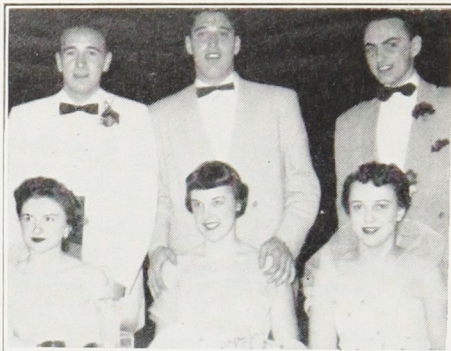

## RHO—UNIVERSITY OF KANSAS

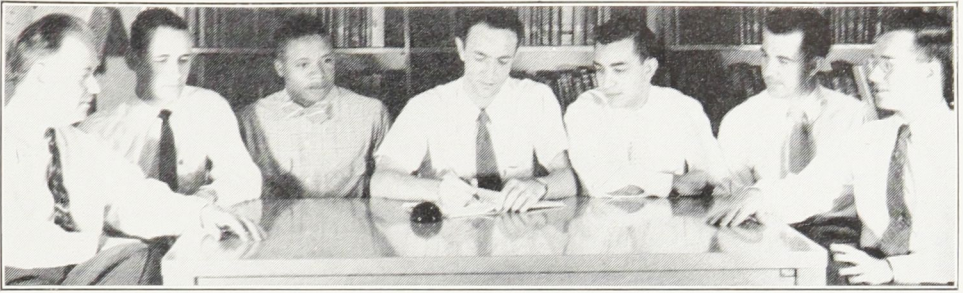

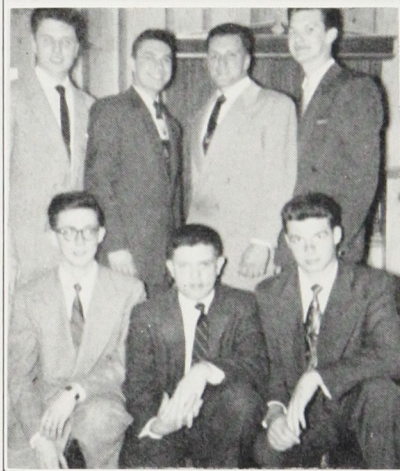

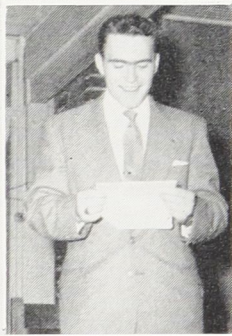
### BETA DELTA—ALBANY COLLEGE OF PHARMACY

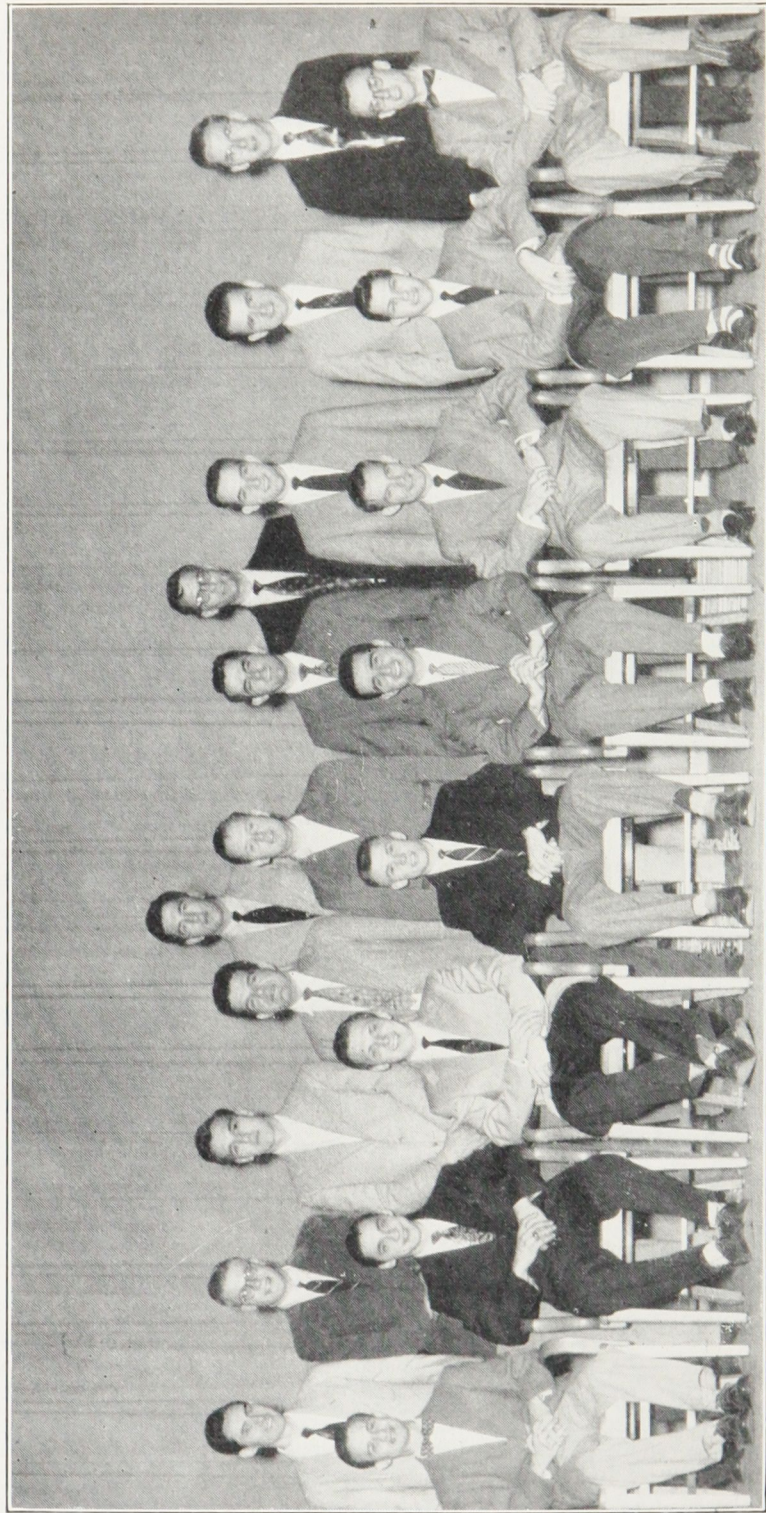
## BETA PSI—UNIVERSITY OF WISCONSIN
