



Why not begin now to plan for the greatest fraternity experience in a life time by attending the National Convention of Kappa Psi in St. Louis at the Congress Hotel on December 28, 29, and 30, 1957.

VISITATION GLIMPSES

On Wednesday, April 24, Grand Regent and Mrs. Fischer departed from Seattle via the airways for a three week visitation of several eastern and southern chapters, and to attend the annual Kappa Psi breakfast at the A. Ph. A. Convention in New York City.

The highlight of the annual breakfast was the presentation of an honorary membership to Dean Louis C. Zopf, College of Pharmacy, State University of Iowa. Our Fraternity has always taken pride in the selectiveness in granting this type of membership. In Dean Zopf we chose a man of high professional ideals, one who is untiring in his efforts toward the betterment of pharmaceutical education, and who has devoted many years in the service of our profession. We are proud to welcome him within our ranks.

Travel plans included the following cities: Buffalo, New York City, Washington, D.C., Richmond, Virginia, Chapel Hill and Charlotte, North Carolina, Charleston, South Carolina, and Gainesville, Florida. A week end in Tampa, Florida, conditioned your G. R. for the long hop to Seattle and a backlog of teaching duties.

We began by crossing the nation to Buffalo where Gamma Iota spread a royal red carpet of welcome in a torrential rain. Close to midnight a fine delegation of brothers and Dr. Kleber met our long overdue plane and after a short nightcap the party escorted us to the pleasant room they had personally selected for us. Five pairs of willing hands dispensed with hotel services to see that our luggage was safely in our room. Red carnations, Kappa Psi's official flower, matched the room's decor and a gift of a large stein bearing Kappa Psi insignia, Buffalo Chapter, and your Grand Regent's nickname "Louie" made us feel very welcome.

We had flown through a terrific electrical storm, buffeted by seventy mile winds but this heart warming welcome made us forget our travel weary selves.

Next day breakfast and a meeting with the officers was followed by a visit with Dean Murray and Dr. Garner. Luncheon at the Hotel Sheraton-Brock, Niagara Falls, Canada, and a tour of Niagara Falls gave us a "honeymoon" 28 years late. (Our colored slides are helping us to relive this beautiful day with our Kappa Psi friends.)

We learned that Seattle's proverbial rains are but misty showers as compared with an eastern cloudburst. Our arrival at the fine dinner-dance arranged for us at the Club Como was delayed when two automobiles were dispatched for us but were flooded out of commission. A taxicab finally took us through a partially blacked out city—the lights having

been "doused" by the rain. Special appreciation for the many kindnesses extended is hereby given to Cass Candell, Bill Kent, Don Arthur, Jan Madejski, John Bukowski, Frank Janik, Dr. Kleber and to these Kappa Psi sweethearts (who made Mrs. Fischer's day memorable), Jane McMahon, Diane Dilapo and Marlene Schoenthal.

At Gamma Tau, Washington, D.C. (after the Convention in New York City), we were met by Regent Quaglia and G. C. D. Koustenis. A brief tour of the capital en route to our hotel was followed by an officers' meeting at the school. A fine dinner meeting gave your G. R. an opportunity to meet more collegiate and some graduate brothers.

Theta Chapter, Richmond, Virginia, sent this delegation to the airport: Robert Sturgill, Jr., Robert Snoddy, Frank Harris, Joe Felts, and Ivan Gattis. Your G. R. enjoyed luncheon with Chapter members, Grand Vice Regent Milton Neuroth, G. C. D. Joe Krezanowski, and George Bender of Parke, Davis & Company. In the afternoon a three hour meeting was held at the Chapter house.

Real southern hospitality was displayed when Mrs. Fischer and your G. R. were driven to Williamsburg and the famous Jamestown Festival by Dr. Krezanowski. We were accompanied on this fine Sunday outing by brothers Frank Harris and Frank Pugh. Theta's G. C. D. Joe Krezanowski has a terrific capacity for friendliness.

Chapel Hill's officers Hugh Hinton and Bill Allen welcomed us at Raleigh airport and drove us to the Carolina Inn. We left a bit of our hearts in Chapel Hill and yearn for time to return again to sit in the rocking chairs on the broad veranda to listen to the enchanting song of the mocking bird. A pleasant dinner at the Kappa Psi house with all members in attendance was enjoyed by Grand Regent and Mrs. Fischer. A business meeting until nearly midnight ended the day.

Late in the planning of this itinerary an extra city was added when your G. R. was asked to speak at the State Convention in Charlotte, North Carolina. Brother Don Miller drove us there accompanied by Satrap Earl Brown. En route we toured Duke University and the famous southern golf club at Pinehurst.

Iota Chapter at Charleston sent a quartet of brothers to welcome us and within fifteen minutes after checking in at our hotel we were on a pre-arranged boat trip to historic Fort Sumter. We were accompanied by brothers Dodd, Denny, Molpus and Saunders.

Several brothers of Kappa Psi plus Dean and Mrs. Prout and Professor and Mrs. Culp were in attendance at a dinner which was followed by a business meeting with G. C. D. Culp and the officers in the G. R.'s hotel room. Later we adjourned to the dormitory where the entire Kappa Psi group held a meeting after 10:30 p.m.

Our departure from Charleston was hectic and it took the skillful driving of exambulance driver Saunders to get us to the airport on time. Mrs. Prout and Mrs. Fischer had been on an early-morning sightseeing tour and delayed in returning to the hotel.

Gamma Sigma in Gainesville was our last official tour of duty on this visitation trip. We were met in Gainesville at the airport by Treasurer Claude Dyal and Historian Millard Ebert and driven to our hotel.

Dr. and Mrs. Carl H. Johnson (G. C. D.) were our hosts at dinner where we spent an enjoyable evening relaxing with these good friends. Next morning Mrs. Fischer and I enjoyed the two hour coffee period held in the Student Union Building. This gave ample time for the various collegiate brothers and faculty to come and go in an informal pleasant manner.

After luncheon a visit with Dean Foote and a tour of the campus and local interest places was arranged. Your Grand Regent made raw meat balls and tossed them to live alligators in a roadside pond—a story doubted by his western friends.

A banquet in the Hotel Thomas was arranged for the last evening. This was a big turnout of brothers. Mrs. Foote, Mrs. Johnson and Mrs. Fischer were invited and left before the business of the evening was begun.

For the purpose of keeping this report as brief as possible, the above account lists in

somewhat skeleton form the highlights of the visitations. If it sounds as though it was all social and sightseeing, please bear in mind that business was the order of the day and a schedule of closely timed appointments made best use of available time with collegiate and facultate members. (Incidentally, your G. R. especially appreciated the detailed schedule of events from two of the chapter Secretaries. These "planning sheets" sent before the trip showed great thought and attention to detail. Thanks, brothers!)

At each chapter, meetings with officers varied from 2 to 4 hours. Discussions were centered around chapter business, methods, duties, activities, et cetera. A three-page questionnaire, used during the past two years, was completed together with suggestions and recommendations of each chapter visited. The reports were sent to Grand Secretary Eby. Every effort was made to clarify chapter procedures and give helpful advice.

In general your Grand Regent was pleased with the operation of each chapter. The fraternal spirit and enthusiasm was outstanding. Each chapter is to be commended for its participation in social and educational activities. Occasional problems were presented and a sincere attempt at solution was made by all.

I close by extending to all my sincere appreciation for the cooperation and friendliness extended to Mrs. Fischer and me. Our hearts are filled with happy memories and we shall long remember the spirit of Kappa Psi's friendly hospitality. Alpha Chapter salutes you—one and all!

Fraternities' Constitutional Rights*

"Good taste is the flower of good sense."-Poincelot

Among traditional rights assured American citizens is the right of freedom to assemble peaceably, the right of association, and the right of privacy. What right have UNESCO zealots and "tolerance organizations" to demand that these rights be chucked out the window where our children are concerned on the campus?

Well, when misguided politicians, professors, and even well-meaning segments of the public attempt to dictate forcibly to private student organizations as to the composition of their own membershipthey are actually denying these important rights to young Americans. Which is un-American in the

extreme and ought to go without saving.

If these young people—or anyone else for that matter—wish to limit membership in their own private societies to left-handed Hottentots, six-fingered nomads, or even riders of the purple sage, just whose business is it except their own? And their parents? Isn't any social group simply the worldly extension of one's own home? And who is the final arbiter to say of who shall come into one's home except the person involved and his or her family themselves? Certainly not the politician! Certainly not the professor or teacher! Certainly not the social do-gooders or vociferous pressure groups! Certainly not anyone at all except Mom and Dad, Buddy and Sis! How can anyone with the least degree of common sense or basic good manners presume to "legislate" social acceptance by the element of compulsion?

The vicious attempt of the UNESCOites and their collaborators to deal a death-blow to the college campus fraternity system by "legislating" unwanted conditions of membership to its members has stirred up a storm of protest in Southern California already. Fraternity men and women are rallying on all sides to strike back at the cunning exponents of this un-American measure which would deny the free agency of students to decide their rights of association, assembly, and privacy for themselves

without outside do-gooders' unwanted interference.

"I have received many letters on this AB 758 and naturally I will be opposing it and also use my influence to the maximum with others," a prominent legislator in Sacramento recently told me. "The authors of this bill are extreme left-wing thinkers, and to be frank with you, I think it is just their slanted philosophy. Personally, I know of no radical connections, but I do know that when their names appear on legislation you want to take two good looks before you act."

Recently I asked Edmund Nichols, president of the Interfraternity Alumni Association of Southern California, what he thought of the controversial bill. Ed is a fine attorney, a staunch patriot who believes in the American Republic to the hilt, and these are his words in reply:

"This law deprives you of the right to choose your own members on any basis you select. It violates the right of privacy and infringes upon the freedom of religion. The greatest bulwarks of our way of life and our democratic freedoms have always been our churches and our fraternities. The forces opposed to our democracy know that they must destroy our traditions and free institutions before we can be subjugated."

If the free fraternity house falls to the corrupt un-American ideology of the totalitarian planners today-whose house will be the next to fall? Will it be your neighbor's? Or perhaps even your own?

Isn't now the time to appraise correctly this situation before it's too late?

Second Grand Vice Regent James R. Thayer Appointed Acting Dean of St. Louis College of Pharmacy

Dr. James Russel! Thayer, Professor of Chemistry at the St. Louis College of Pharmacy and Allied Sciences since 1930 and Associate Dean since 1950, and Second Grand Vice Regent of Kappa Psi Pharmaceutical Fraternity has been appointed Acting Dean of the St. Louis College, effective September 1, by action of the Board of Trustees of the College, He succeeds Dean Arthur Floyd Schlichting, who has been named Dean Emeritus. Brother Thaver came to the St. Louis College of Pharmacy from the College of Pharmacy of the University of California in 1930 to succeed Professor Charles E. Caspari as Professor of Chemistry. Dr. Caspari had been Professor of Chemistry since 1903 and Dean of the College since 1926. Upon the death of Dean Caspari in 1942 Professor Schlichting was appointed Dean and is now completing his fif-961 teenth year in that capacity.

Dean Thayer holds the A.B. degree from Ohio University and the M.S. and Ph.D. degrees from the University

of Wisconsin. Before going to California in 1929 he had been engaged in research for Parke, Davis and Company. In addition to his duties as Associate Dean, Dr. Thayer has been teaching in the fields of organic chemistry, synthetic organic medicinals, and biochemistry. He has been honored by the St. Louis College with the Certificate of Service Award and by the St. Louis College of Pharmacy Alumni Association with the Distinguished Service Plaque.

When interviewed, Brother Thayer responded in characteristic fashion: "I was born in '97 on a farm near Medina, Ohio—eighty-five acres and a whopping mortgage. Plodded through a mile of mud to get to school in Medina and then did everything possible to alienate the teachers. Finally graduated from high school as Class Prophet in 1917. (The mud road was now gravel.) Started higher education at Ohio University with lots of hope but neither brains nor finances to back it up. Lived on soup 'n' crackers, worked in a brickyard, staggered home in January with acute bronchitis. Returned to college in the fall of '18, put on an S.A.T.C. uniform, carried bed pans for three months during the flu epidemic. Discharged after the Armistice, I was broke again. Worked for B. F. Goodrich building tires. During summers I farmed, painted, and worked in a saw mill. 1921-22 1 had an assistantship in the Ohio University chemistry department. 1922-23 I was principal of Milford, Ohio, High School; that was all they could stand, so I taught at Gibsonburg, Ohio, during 1923-24. Reported at the University of Wisconsin for graduate work in the

fall of 1924. Was given an assistantship in 1925, and M.S. degree in 1926, and a Ph.D. degree in 1928. Reported for research job with Parke, Davis and Company in the summer of 1928, and in the summer of 1929 received a teaching appointment at the California College of Pharmacy. One year was all they could take, so the next year they unloaded me on St. Louis. While I was en route to St. Louis my car and everything else that I owned was stolen. Dean Caspari grinned, invited me into his home, and introduced me to St. Louis hospitality. St. Louis became my home, the happiest home I have ever known."

The new dean has held various national and regional offices in Kappa Psi and is currently our Second Grand Vice Regent. He is a member of the A.Ph.A., the A.C.S., the A.A.A.S., the Missouri Pharmaceutical Association, and Rho Chi. Brother Thayer has always been deeply interested in the advancement of pharmacy in general and of the St. Louis College of Pharmacy in particular, but his former and present students, particularly the members of Gamma Pi Chapter, know that he is even more concerned with the problems and welfare of each individual student and alumnus. A veteran fisherman and bowler, and an ardent conservationist, Brother Thayer's love of the outdoors is shared by his charming wife and his two lovely daughters, with whom he makes his happy home at 7816 Murdoch Avenue, Webster Groves 19, Mo. The Mask wishes the new dean at St. Louis continued happiness and satisfaction in guiding and advising the young people who will be our pharmacists of tomorrow. Congratulations, Brother Thayer, and good luck in your new post.

Poison Control Centers

At the New York Convention of The American Pharmaceutical Association held April 28-May 3, 1957, one of the several resolutions adopted was as follows:

Resolved, That the American Pharmaceutical Association reaffirm its endorsement of the development of a coordinating program for poison control centers as proposed by the Public Health Service of the Department of Health, Education and Welfare; and be it further

Resolved, That the American Pharmaceutical Association urge its members to participate to the fullest extent in the development of local poison control centers and offer their cooperation in serving their respective communities in gathering and dissemination of information with respect to antidotes and treatment facilities for accidental poisoning from various sources.

The House of Delegates approved the resolutions. The Council instructed the Secretary to notify the Public Health Service of the action taken and offer cooperation of the A.Ph.A. to all state pharmaceutical association secretaries in setting up and making effective local poison control centers.

University of Iowa Dean Awarded Honorary Membership


EDITOR'S NOTE: The following presentation was made by Grand Regent Louis Fischer on the occasion of Dean Louis C. Zopf being made an honorary member of Kappa Psi at the Kappa Psi breakfast held during the A.Ph.A. Convention in New York City on May 1, 1957.

Kappa Psi Pharmaceutical Fraternity provides in its Constitution for four types of memberships: Collegiate, Graduate, Facultate, and Unaffiliated. In addition honorary memberships are given in recognition of distinguished service in the field of pharmacy.

As the highlight of this annual Kappa Psi breakfast we pay honor to a fellow pharmacist and educator who by his untiring efforts, high ideals and good judgment, has attained numerous worthy achievements. Dean Louis C. Zopf has been elected to Honorary Membership in Kappa Psi.

Dean Zopf was born in Marengo, Iowa, August 28, 1904. He attended the University of Iowa and received his Ph.G., B.S. and M.S. degrees. In 1954 from the University of Nebraska he received an Honorary Sc.D.

Our recipient's experience in pharmaceutical fields has run the gamut in the profession. He served for some time in the retail field as a registered pharmacist, followed by becoming Manager, Department of Drug Service, College of Pharmacy, State University of Iowa. 



Installation of Gamma Theta Chapter

By James R. Thayer, Second Grand Vice Regent

It is embarrassing but true that as we grow older—and most of us do—we are increasingly thrilled from being associated by youth and growth. For that reason and others I was particularly delighted to install our newest Chapter at the University of Kansas City, Kansas City, Missouri, on May 17, 1957.

I would like to memorialize the occasion by directing a few simple remarks to three interested groups—the New Chapter—all of the old Chapters and Alpha Chapter.

When I refer to the New Chapter my thinking includes Collegiate Members, Facultate Members (I hope Dean Eisenbrandt will not be offended at my ineptness in mixing Faculty and Administration) and our able and enthusiastic Brother, Dr. Rost. I wish to bestow a verbal laurel wreath on the brow of that gentleman. I am sure that his energy, enthusiasm, tact and hard work was the main factor in bringing about this latest expansion of Kappa Psi. I would like to commend the whole group for their cooperation and patience. From my observations of the group and my conversation with many individuals I can say that we are proud you have joined us. I am sure that you already subscribe to the most fundamental object of Kappa Psi—THE ADVANCEMENT of PHARMACY.

To the established chapters of Kappa Psi I direct the following remarks. The addition of a new Chapter to Kappa Psi should make you feel proud of your contributions to that organization. If you had not made Kappa Psi what it is—no group would have any incentive for joining you. We often feel that what we do as an individual or as a group is unimportant. Nothing could be more untrue. Admittedly no one of us even approaches perfection. It is equally true that unless an individual (you and I) or a group (Chapter) exhibits a constant reputation as continuous contributors to some constructive purpose—no one will buy the merchandise that we display on the counter. I am certain that no one gave the New Chapter a sales talk on this. I do not believe they were detailed on what Kappa Psi has done and is doing for Pharmacy or Civilization. I am equally sure that every one of the group before deciding to join us—sensed or felt that we were worthy of joining. You have established a fine tradition. Perpetuate it in every way you can.

To Alpha Chapter I direct the following remarks. When I speak of Alpha Chapter I mean the one that is, those that have been and those that will be. The addition of Gamma Theta Chapter is a tribute to your leadership and that leadership must continue. To some extent we are all parasitic—we have to lean on the larger group. It is the responsibility of Alpha Chapter to make the sustaining strength of the whole group available to all of its segments. No mean task. I am perfectly aware of the obstacles that make this a herculean task. I am also aware that we must in some way bridge these obstacles. We must find the means of living up to our motto—"one for all and all for one."

A Brief History of the University of Kansas City, Kansas City, Missouri

The University of Kansas City was granted a charter in 1929. The first classes enrolled in 1933 and accreditation by the North Central Association of Schools and Colleges was received in June, 1938.

In 1938 the Kansas City School of Law became the School of Law of the University. In 1941 the Kansas City Western Dental College which was founded in 1881, became the School of Dentistry of the University. In 1943 the Kansas City College of Pharmacy which was founded in 1885, became the School of Pharmacy of the University. In 1935 graduate study was introduced for the Master's degree within specified fields on Liberal

Arts. A curriculum in nursing is offered in conjunction with the General Hospital and the Research Hospital as well as the Trinity Lutheran Hospital. In 1953 a School of Business Administration was established and in 1954 doctoral study was introduced in the School of Education which offers the B.A. degree, the M.A. degree and the Ph.D. degree. In 1954 the B.S. degree in Sciences, Medical Technology and Home Economics were added and the LL.M. degree in Law was established. The first class in Dental Hygiene was graduated in 1954.

History of the School of Pharmacy, University of Kansas City

The origin of the school dates back to 1885 when a body of men prominent as pharmacists and physicians met and formulated plans for advancing the science of pharmacy and designated that such institution should be known as the Pharmaceutical Department of the University of Kansas City.

After a period of four years, in October of 1889, this organization was incorporated as the Kansas City College of Pharmacy, under the State Laws of Missouri and continued under this charter, meeting with success and occupying the University Medical College building.

In 1898 this school was reorganized and incorporated as the Kansas City College of Pharmacy and Natural Science Association,

In September, 1939, this school was reorganized and incorporated as the Kansas City College of Pharmacy and Science and was operated under the charter issued on September 19, 1939.

In 1920, two years of high school as prerequisite to the two year course became necessary. In 1923 a certified high school diploma from an accredited high school became a requirement. In 1926 the three year curriculum was instituted and in 1932 the four year program was adopted with the degree B.S. in Pharmacy.

In 1943 the University of Kansas City acquired the School of Pharmacy and moved it from the downtown location to the Volker Campus, housing it in the Chemistry-Biology building. In September, 1947, it moved into its own building. Dr. T. T. Dittrich was the first dean after the school's affiliation with the University. He continued in this capacity until 1953. Dr. L. L. Eisenbrandt became dean in August, 1953.

The School of Pharmacy is accredited by the American Council on Pharmaceutical Education as a Class "A" School, and is a member of the American Association of Colleges of Pharmacy.

The facilities of the school are good. All chemistry courses are taught in cooperation with the Liberal Arts in the chemistry department; the pharmaceutical chemist maintains an office and research laboratory in that department. The laboratories are excellent and fully equipped. The various biology courses are taught in the biology department of the Liberal Arts College which likewise is a well-equipped department in every respect. Pharmacognosy is taught in one of the pharmacy laboratories by pharmacy staff members. Physiology is taught in the dental building. This laboratory, too, is well equipped. Physics is taught in the Liberal Arts physics department in a well-equipped laboratory.

The professional pharmacy courses are taught in the pharmacy building. On the first floor are offices, a preparations laboratory and a dispensing laboratory. A dispensary is located on this floor as well as stock rooms. On the second floor is a large lecture hall, a manufacturing laboratory, reading room and the pharmacology department. The animal room is well cared for and in good condition. One room is limited to graduate study and research. In the general laboratory there are D.C. and A.C. power lines, oxygen and gas lines to the pharmacology tables. Compressed air is also available.

The school is unusually fortunate to have the Linda Hall Scientific Library available.

Through this library all books and journals in the pharmacy field (and other sciences) are available. This library is across the street from the university library mentioned previously. All scientific books and periodicals of the university are maintained at Linda Hall Library. Over 4500 periodicals in the sciences are subscribed to; 1500 are from outside the United States. There are well over 60,000 bound volumes (not including periodicals). Complete microfilm service is available. In short, the library facilities are of the best.

Prominent Pharmacognosist Becomes Member of Kappa Psi


Edson F. Woodward, Jr., Chief Pharmacognosist of S. B. Penick and Company as well as assistant to the president, became a Graduate Member of Kappa Psi at ceremonies held at the Massachusetts College of Pharmacy on the afternoon of Tuesday, June 4, 1957. A number of present and past officers of Mu Chapter took part as did several faculty members from the College. Mu Chapter feels highly honored to have Brother Woodward as a member of its group and of our national organization.

This new member of Kappa Psi was born in New Hampshire on January 18, 1918. He received the degree of bachelor of science from the Massachusetts College of Pharmacy in 1939 and the degree of master of science from the same institution in 1941. During his

undergraduate days he served as vice president of his senior class. Later he served as president of the Student Council at the College and president of the local Rho Chi chapter.

Mr. Woodward joined the Penick Company in September, 1941 and has remained with the company ever since except for time spent in the medical department of the United States Army during 1942 and 1943. He led the Upjohn-Penick Expedition to Africa in 1950-1951. Since then he has traveled extensively in various parts of the world, especially in Central America and India searching for new drugs and new drug sources. He is in charge of the various associate companies of S. B. Penick located in London and Paris.

On May 30, 1942, Mr. Woodward married Ruth Fleming. They have a daughter, Elizabeth. The Woodwards consider 105 Edison Street, Wyckoff, New Jersey, as home. However, they also lived in London, England.

"Whereas, The genial and popular Director of the Pharmacy Commission, Dr. Felix Blanc, has received well-deserved recognition by his colleagues of his ability in his chosen field by his election as President of the National Association of Boards of Pharmacy; and

"WHEREAS, The members of this assembly wish to make due acknowledgment of this honor to a man who has thus brought distinction to himself and to his state; now

"Therefore Be It Resolved, That heartiest congratulations and warmest good wishes for a successful term of office be extended to our good friend, and

"Be It Further Resolved, That the clerks of the House and Senate cause a copy of this resolution be sent to Dr. Blanc as a token of our esteem."

Connecticut pharmacists, who are jubilant over Dr. Blanc's elevation to high national office, regard this as a personal tribute to Dr. Blanc, under whose tireless and dedicated leadership the Connecticut Pharmacy Commission has become one of the most effective and well functioning agencies of its kind in the nation.

Born in Athol, Massachusetts, September 6, 1894, Felix Blanc has been a resident of Connecticut since the age of two, when his parents moved to Bethel, where he later attended grade and high schools. He first entered the pharmaceutical field as an employee of the Patrick Garvin Pharmacy in Bethel, subsequently moving to Hartford to work for the Goodwin Drug Company. He left Goodwin's to serve his country for three years during World War I, and upon his return he became associated with the Stoughton Drug Company of Hartford.

Dr. Blanc became licensed to practice pharmacy in Connecticut in 1922. Ten years later he was engaged by the Connecticut Pharmacy Commission to serve as a drug inspector. After functioning in that capacity for three years he became chief inspector and in 1944 he became Executive Secretary of the Commission. Since 1948 he has been Director of the Commission.

Under his leadership the Commission has made many much needed regulations and has sought vital legislation to tighten the control of drug distribution. But even today, he and the Commission realize that much remains to be done to revise and modernize many of the statutes in the interests of the public.

Dr. Blanc is one of the far sighted leaders whose determined activities have brought about the modernization of Connecticut's system of pharmaceutical education and it was largely through his efforts that Connecticut now has on the campus of the University of Connecticut one of the finest colleges of pharmacy in the United States.

Dr. Blanc is known in the Legislature as the "watch dog" of pharmacy. At each session proposals are advanced by lay persons, directed at laws governing the sale of drugs, and these are given careful scrutiny by Dr. Blanc and the Commission, who endeavor to see that unfavorable legislation is not foisted upon the people of Connecticut.

In the month of June, 1954 the Rhode Island College of Pharmacy and Allied Sciences conferred upon Felix Blanc of Hartford, the honorary degree of doctor of pharmacy. He was made an Honorary Member of Kappa Psi on January 16, 1952.

You Should Know . . .

LEWIS NOBLES, Satrap of Province VII and Grand Council Deputy of Beta Rho Chapter, was born in Meridian, Mississippi, on September 11, 1925. Graduating from the Meridian High School he attended the Meridian Junior College for one year before enrolling in the school of pharmacy of the University of Mississippi in 1943, After completing one year in the school of pharmacy, he entered the U. S. Navy for approximately 27 months. During this time, he spent two semesters at Ursinus College, Collegeville, Pennsylvania before going to U.S.N.R. Midshipman's School at Columbia University from which he received his commission as ensign in the U.S.N.R. in 1945. After release from active duty, he returned to the school of pharmacy at the University of Mississippi in September, 1946. He was instrumental in reactivating Beta Rho Chapter, which had become dormant during the days of World War II, in May, 1947. He received his B.S. in Pharmacy degree in May, 1948. Shortly thereafter he entered the graduate school of the University of Mississippi from which he received the M.S. degree with a major in organic chemistry in August, 1949. In the next month, he entered the graduate school of the University of Kansas where he pursued a course of study leading to the Ph.D. degree, with a major in pharmaceutical chemistry. For the three years that he was at the University of Kansas, Dr. Nobles was the recipient of an American Foundation for Pharmaceutical Education Fellowship.

After graduating in May, 1952, he went back to his alma mater where he had accepted the position of assistant professor of pharmacy and pharmaceutical chemistry. In September, 1954, he was promoted to the rank of associate professor and one year later was elevated to the rank of professor of pharmacy and pharmaceutical chemistry. During the 1955-1956 and 1956-1957 school years he was the recipient of a Gustavus A. Pfeiffer Memorial Research Fellowship, which allowed him to continue his active interest in the synthesis of potential medicinal agents derived from 3-substituted thiophenes. More recently, he has been awarded a Science Faculty Teaching Fellowship from the National Science Foundation to allow him to pursue post-doctoral studies at the University of Michigan and Purdue University.

On August 29, 1948, Brother Nobles and Miss Joy Ford were married. Mrs. Nobles, who was a student in the school of pharmacy at the time of the marriage, received her B.S. in Pharmacy degree in May, 1949. They have one daughter, Sandra Jeanne, who is six years of age.

Some of the other organizations to which Dr. Nobles belong are: Phi Lambda Upsilon, Rho Chi Society, Omicron Delta Kappa, Sigma Xi, Pi Kappa Alpha, American Pharmaceutical Association, American Chemical Society, and the American Association for the Advancement of Science. These are in addition to his state pharmaceutical association and other local and regional professional groups in pharmacy and chemistry.

Province III Assembly

Chapel Hill, North Carolina, April 13, 1957

The Province III Assembly was held at the Institute of Pharmacy in Chapel Hill, North Carolina, Saturday, April 13, 1957. Representatives of Collegiate Chapters Beta Xi, Theta, Iota, and Gamma Tau were in attendance. No representation was present from Beta Eta Chapter or from George Washington Graduate Chapter.

The meeting was called together by Satrap Earl T. Brown at 10:15 a.m. This was followed by an invocation delivered by Seth Miller (Beta Xi). Regent Hugh Hinton of the host-chapter Beta Xi welcomed the members assembled.

The Secretary's report which had been written by John W. Boenigk (past secretary) was read by Brother Semeniuk. This report was based on the proceedings of the Province III Assembly which had been held in Atlanta, Georgia, on April 23, 1955. Following this, the Treasurer's report was given which showed a balance of \$149.17 in spite of certain delinquencies in the payment of dues by some Chapters.

A discussion period followed relative to Province finances and the problems of the Treasurer relative to collection of dues. The following motion was made by Brother Semeniuk as an amendment to the By-Laws: "That Province dues by member-chapters be assessed and collectable as of April 1 of each year on the basis of active membership in each chapter as of that date." The motion was deliberated upon until the final session, seconded by Brother Alexander of Beta Xi, discussed and passed. Only Legislative approval remains for the activation of this amendment.

Further discussion hinged upon the expressed desirability that the officers of the Province be distributed more geographically in the future. It was anticipated that the Nominating Committee would attempt to effect this condition.

At this time the floor was given over to an address by Supervising Grand Officer and Grand Secretary-Treasurer Frank H. Eby whose talk revolved about the general affairs of the Fraternity in terms of growth in Chapter, Province and National scales.

The meeting adjourned at 12:20 P.M. for an enjoyable luncheon at the Beta Xi Chapter House. Guest speaker at the luncheon was Mr. Roy Armstrong, Director of Admissions at the University of North Carolina.

At the afternoon session which opened at 2:30 P.M. each of the represented member-chapters was called upon to report on the activities and accomplishments it experienced since its previous assembly report in Atlanta.

The following committee reports were then given:

Resolutions Committee—(recommended and passed): 1. That the Secretary be instructed to write the Secretary of the North Carolina Pharmaceutical Association (Mr. W. J. Smith) expressing gratitude and thanks for the use of the Institute of Pharmacy for this Assembly gathering; 2. That the Province delegate to the coming National Convention be instructed to present the following proposal: That the national body make a study to determine the possible effects of the 5-year program upon the membership of Kappa Psi in the future.

Time and Place Committee—(recommended and passed): That the next Province Assembly be held in Richmond, Virginia, with Theta as host-chapter. Suggested date was the second week of April, 1959, with the exact date and time to be set by the Executive Committee by known circumstances at the time.

Nominations Committee—(recommended and passed): Satrap, Earl T. Brown (faculty, University of North Carolina); Vice Satrap, G. L. Geiler (faculty, West Virginia); Secretary, John Andrako (faculty, Medical College of Virginia); Treasurer, Gus Koustenis

(faculty, George Washington); and Historian, J. Z. Krezanoski (faculty, Medical College of Virginia). The Delegate and Alternate Delegate elected for representation of the Province at the National Convention at St. Louis in December of 1957 were, respectively, Bill Allen (Beta Xi) and Mike Lazarus (Beta Xi).

The Province III Assembly adjourned at 4:30 P.M. This was followed by a Beta Xi

dinner and reception.



Brother Henry A. Langenhan Dies

Kappa Psi mourns the passing of one of its great contributors in the early years of the professional phases of the Fraternity. Not only was Brother Langenhan an active member for many years but also served on the Editorial Board and Extension Committee for a number of years. He was also secretary of the former Northwest Province of Kappa Psi. He was 74 years old when he died in Seattle, Washington.

Dr. Langenhan was at one time a member of the Department of Pharmacy at the University of Washington where he retired in 1953. He first joined the university in 1922 as an associate professor. He resigned in 1939 to go into private business.

In 1947 Dr. Langenhan returned to the faculty as a part-time lecturer in pharmacy. He was born in Ableman, Wisconsin. He was graduated from the University of Illinois College of Pharmacy. He received his master's degree from the University of Wisconsin in 1915 and in 1918 received the first doctorate given in pharmacy in this country.

For several years Dr. Langenhan was a practicing pharmacist and analytical chemist. He began his teaching career in 1908 at the University of Illinois and also taught at the University of Wisconsin before he came to the University of Washington.

From 1930 until 1950 Dr. Langenhan was a member of the United States Pharmacopoeia Revision Executive Board. He was vice president of the American Association of Colleges of Pharmacy in 1930 and 1931 and chairman of the scientific section of the American Pharmaceutical Association in 1929 and 1930.

In 1934 Dr. Langenhan received the Ebert Prize for his research in pharmaceutical problems.


