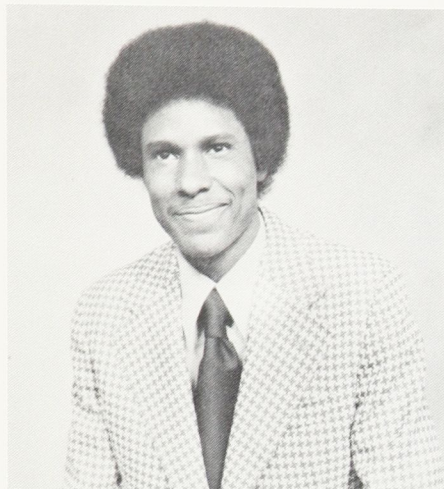

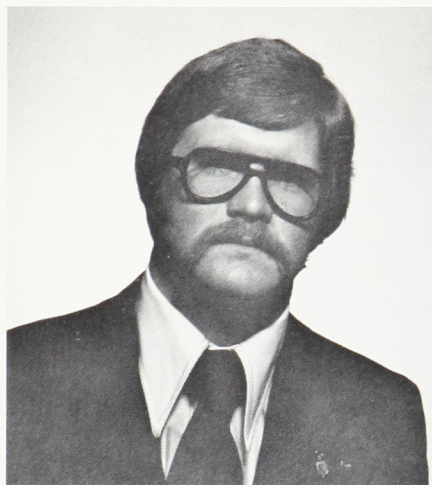

The 38th Grand Council Convention was held in Philadelphia at the Holiday Inn - Penn Center. The Convention was scheduled to coincide with the bicentennial celebration (July 4 to July 7) attracted over 240 collegiate and graduate members. John Atkinson, Jr. served as the General Convention Chairman. Members from Beta Omega Chapter (Temple), Eta Chapter (Philadelphia College of Pharmacy and Science) and the Philadelphia Graduate Chapter served as co-hosts for the Convention. Other committee chairmen included: Leonard Naeger - Credentials; Dewey Garner - Resolutions; Louis Fischer - Nominations; Jerome Delaney - Parliamentary; Registrations - John Viercinski and Bob Carol.

During the Second General Session, workshops were conducted on various important issues affecting the Fraternity such as women in Kappa Psi under Title IX, a meaningful pledging program, the service organization (Little Sisters), and the initiation of the Chapter Achievement Award.

The Fifth General Session of July 7, 1976 included the election and installation of new national officers. These Brothers will lead the Fraternity for a term of three years into our own centennial celebration in 1979. Those elected were: Grand Regent - William A. Fitzpatrick; First Grand Vice Regent - Dewey D. Garner; Second Grand Vice Regent Patrick R. Wells; Third Grand Vice Regent - Joseph Miletta; Grand Historian - Leonard Naeger; Grand Counselor - Jerome P. Delaney; Grand Ritualist - Larry Slater; and Graduate Member-at-Large - William R. Smith. Donald Floriddia and Chris Gong will continue as Executive Secretary and Assistant Executive Secretary, respectively.

Special Guests included President John Bergen of Philadelphia College of Pharmacy and Science and Dean Joseph McEvella of Temple University school of pharmacy. Dr. Frank H. Eby, past Grand Regent and Grand Secretary-Treasurer, honored the Convention by addressing the Third General Session. Dr. Eby received a standing ovation from those in attendance.

The 97th Anniversary Banquet and Dance was held after the closing ceremony on July 7, 1976. The next national convention will be held in Scottsdale, Arizona in the summer of 1979. That will mark the 100th anniversary of Kappa Psi Pharmaceutical Fraternity.

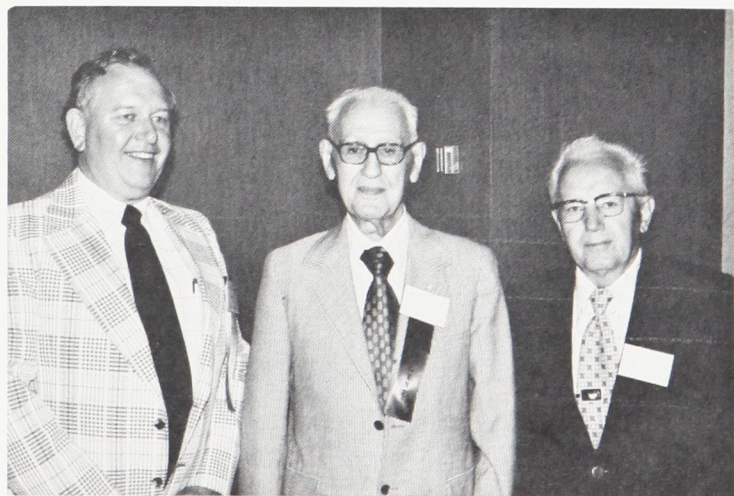

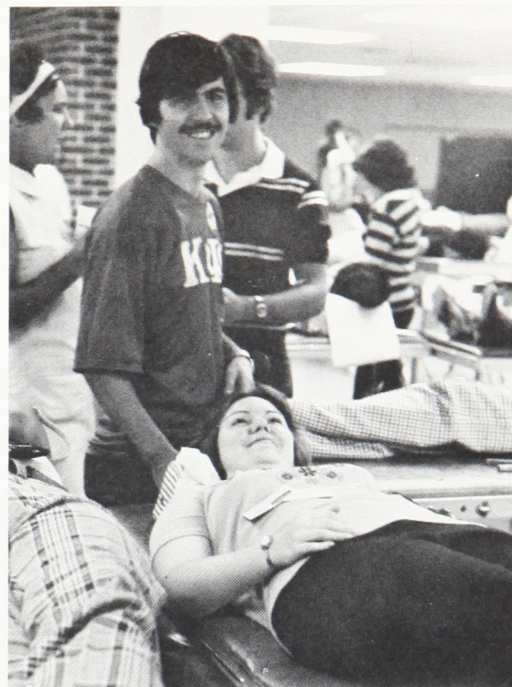

PROFILE OF A RECIPIENT THE ORDER OF THE GOLDEN MORTAR



Ralph W. Clark (Beta Psi)

Brother Clark was born in Prophetstown, Illinois on January 3, 1901. He started his college education at Cornell College in Mt. Vernon, Iowa in 1918 and then entered the University of Wisconsin in 1920 where he received his B.S. in Pharmacy in 1922. It was there that he was elected to membership at Beta Psi Chapter.

PROFESSIONAL EXPERIENCES

After graduation, Brother Clark practiced both community and hospital pharmacy. He again returned to Wisconsin and received his M.S. in 1929 and his Ph. D. in 1933, remaining there on staff until 1937. For eight years, he was Director of Pharmacy Services at Merck and Company. He left Merck to become Corporate Manager of Pharmacy of all prescription departments in all stores of Macy's New York. He left the business world for academia in 1946 when he joined the University of Kansas as Professor of Pharmacy. In 1949, Brother Clark was named Dean and Professor of Pharmacy at the College of Pharmacy, University of Oklahoma. For fourteen years at Oklahoma he had an outstanding record as an educator and administrator. After his retirement in 1963, the University of Oklahoma bestowed the title Dean Emeritus and Professor Emeritus, an Honor he certainly deserves.

ACTIVITIES

Brother Clark is a life member of A.Ph.A. and has been active in state association work. He holds membership in several professional organizations and societies and has had numerous publications in the area of pharmacy. In addition, he has been active in public service organizations having served as a member of the Board of Directors, Oklahoma Medical Research Foundation and chairman of the Pharmacy Research Commission. He has appeared as a speaker at various service clubs, high schools and colleges, and has appeared on television in Oklahoma. One newspaper referred to him as a "one man crusader against dangerous drugs". Brother Clark served the Fraternity as its Grand Ritualist from 1947 to 1950, resigning when he became Dean at Oklahoma. He is an avid stamp collector and is extremely fond of music. He has "a collection of LP's and tapes ranging from Dixieland Jazz to Grand Opera - no Rock!" In addition, his wife Virginia "does not object to his rather good cooking abilities."



Raymond E. Rodgers (Beta Kappa) has been named regional sales manager of the west central region for Eli Lilly and Company. He had been manager of one of the Boston sales districts since early 1974.

Rodgers joined the pharmaceutical manufacturer as a sales representative in Columbus, Ohio, in 1963. In 1969 he was transferred to the firm's Indianapolis headquarters as a marketing analyst. He held management positions in quotations development and marketing plans before being named manager of the Richmond, Va., sales district.

Born in Youngstown, Ohio, Rodgers was graduated from Woodrow Wilson High School there in 1958. He received a Bachelor of Science degree in pharmacy in 1962 from the University of Pittsburgh. He is registered as a pharmacist in Ohio and Pennsylvania.

PRESIDENT'S COMMISSION ON WHITE HOUSE FELLOWSHIPS THE WHITE HOUSE ANNOUNCEMENT

The President has announced the start of the thirteenth nationwide search for outstanding young men and women to serve as White House Fellows.

Established in 1964, the White House Fellowship program is designed to give rising leaders one year of firsthand, high-level experience with the workings of the Federal Government and to increase their sense of participation in national affairs. The program is open to U.S. citizens from all fields who are not less than 23 and not more than 35 years of age. Employees of the Federal Government are not eligible, with the exception of career armed services personnel.

Members of the eleventh group of White House Fellows are now completing their year long assignments. A twelfth group, the 1976-77 White House Fellows, will begin their duties next month.

In addition to their educational assignments with the Vice President, Cabinet officers or principal members of the White House staff, the Fellows participate in an extensive seminar program, typically consisting of some 300 off-record sessions with top government officials, scholars, journalists, and leaders from the private sector. The young men and women who have, to date, been selected as White House Fellows have included lawyers, scientists, engineers, corporate business entrepreneurs, scholars and academic administrators, writers and journalists, medical doctors, social workers, architects, and local public officials. Last year 2,864 persons applied for the coveted honor.

The Fellowship is designed to be a one-year sabbatical in public service. Fellows are expected to return to their professional careers at the end of their experience in government, with their perspectives of national issues broadened and their qualifications for significant service in their chosen careers and their communities permanently enriched.

Leadership, intellectual and professional ability, high motivation, and a commitment to community and nation are the broad criteria employed in the selection process.

Requests for applications for next year's program must be postmarked not later than November 1, 1976. Application forms and additional information can be obtained by sending a postal card to the President's Commission on White House Fellowships, Washington, D.C. 20415.
